Among other things, you may also use our Services to purchase and sell digital assets directly from and to us and to interact with Cryptocurrency experts and other stakeholders of the IMTC Ltd digital assets management team in various ways as further described in the complete Terms of Service.

# **Eligibility and Acceptable Use-**

You must meet certain eligibility criteria to use imodtrade.ltd/ services. For instance, you must be an adult. Additionally, there are certain things you cannot do when using imodtrade.ltd/ investment/trading platform services, such as engage in illegal activities, lie, or do anything that would cause damage to our services or systems. # **Accuracy of Information-**

You must provide any information required when creating a iModTrade Investment Account or when prompted by any screen displayed within the Services. You represent and warrant that any information you provide via the Services is accurate and complete.

#### **Cancellations-**

You may only cancel an offer, bid, or order initiated via the Services if such cancellation occurs before iModTrade Ltd automated system executes the transaction; and provided that iModTrade Ltd does not otherwise place limits on your ability to cancel an offer, bid, or order initiated by you through the Services. Once your offer, bid, or order has been executed, you may not change, withdraw or cancel your authorization for iMODTrade system to complete such transaction on your behalf. #### Insufficient Assets-

If you have an insufficient amount of Assets in your iModTrade.ltd/ Investment Account to complete a transaction via our Provided Services, we may cancel the entire transaction or may fulfill a partial transaction using the amount of Assets currently available in your iModTrade Investment Portfolio.

#### Taxes-

It is your responsibility to determine what, if any, taxes apply to the trades/investments or transactions you complete via the Services, and it is your responsibility to report and remit the correct tax to the appropriate tax authority. You agree that iModTrade is not responsible for determining whether taxes apply to your trades or for collecting, reporting, withholding or remitting any taxes arising from any trades or transactions from you.

### iModTrade Pte Ltd Investment Portfolio Assets:

#### Funding your iModTrade Pte Ltd Account.

In order to complete an offer, bid, order, trade, investment or transaction via the Services (including orders and trades on the iModTrade Investment platform. First, you must load Assets to your iModTrade Investment Portfolio using one of the approved deposit methods identified via the Services. You may be required to verify that you control the External Account that you use to load Assets to your iModTrade Investment Portfolio. Also, you may

Proceeds from the sale of Digital Assets or Investment for Legal Tender will be credited to your iModTrade Investment Portfolio, less any transactional or other fees or commissions. iModTrade does not pay interest on balances held in your account.

# **Digital Assets Only Accounts -**

➤ If you have opened an iModTrade Investment Portfolio designated as Digital Assets Only, you may only fund your account with Digital Assets or cryptocurrencies such as Bitcoin, Perfect money (PM), USDT (ERC20) and (TRC20), Ethereum (ETH) and LITECOIN respectively.

# **Payment Method.**

Only valid payment methods specified by us may be used to deposit and invest, as applicable. By placing an order to purchase deposit Cryptocurrency into iModTrade, you represent and warrant that (a) you are authorized to use the designated payment method and (b) you authorize us, or our payment processor, to charge your designated payment method. If the payment method you designate cannot be verified, is invalid or is otherwise not acceptable, your purchase order may be suspended or canceled automatically. You agree to resolve any problems we encounter in order to proceed with your purchase order.

#### No Returns or Refunds -

All investment and purchases of Digital Assets or NFTs from iModTrade via the Services are final. We do not accept any returns or provide refunds for your purchase, deposit of Digital Assets or NFTs into iModTrade, except as otherwise provided in these Terms.
